## Terms of reference:

- 1. Prepare a road map for the preservation of the larger water body of Umiam lake and the smaller seasonal ones around the lake;
- 2. Road map should address issues plaguing the Umiam lake;
- 3. Road map shall provide long term and short term measures for preservation of the delicate ecology surrounding the waters, including smaller seasonal water bodies around the lake and preservation of the flora and fauna;
- 4. The Committee shall conduct inspections of Umiam lake to gather relevant
- 5. The Committee shall monitor and coordinate the implementation of road map
- 6. The Committee shall hold sittings once in every fortnight;
- 7. The Committee shall submit preliminary report on road map within 2 (two)
- 8. TA/DA and sitting Fee for non-official members shall be paid as per existing
